

# Honley Day Care

## Fee / Funding Structure

For eligible working parents, we receive 30 hours of funding for 38 weeks of the year which we stretch out to give 22 funded hours over 52 weeks. We generally offer the funded hours as a core package over 3 days between the hours of 09:00-17:00. We ask for a consumable charge of £9 for each of the 3 funded days, which together with the additional 2 hours attended on this core package, is a total of £57/week (£247/month). You can then add on the 07:30-09:00 session, or the 17:00-18:30 session at £6/session/day to suit your requirements.

If you only require 2 days of childcare, then we offer the funded hours as 2 x 08:00-18:00 sessions. This contract would typically include a Monday and/or a Friday. As we are only able to offer a maximum of 10 funded hours per day, the additional 2 hours of funding per week can be accumulated to use as additional sessions throughout the year, as and when required. Here we ask for a consumable charge of £10.50 for each of the 2 funded days, which is a total of £21/week (£91/month).

Our nursery fees are annualised to give parents the same monthly fee throughout the year. This is calculated by taking the weekly fee of your child's sessions, multiplying by 52 and dividing by 12. All absences/holidays (including bank holidays) are charged for at normal rate.

Please note that a late collection fee of £12 will be charged in the event that your child is not collected on time, and no prior arrangements have been made with the Nursery.

## Consumable Charge

The Early Years Government Funding is provided for settings to offer a basic provision of the Early Years Foundation Stage (EYFS), which meets the statutory requirements. It is not intended to cover the cost of consumable items such as meals, snacks, nappies, wipes, etc; nor cover any additional activities or experiences that the nursery may offer.

At Honley Day Care & Pre-Prep School, we strongly believe that early years education should be rich, engaging and full of real-world experiences. To go above and beyond the basic requirements, and provide the quality of care and education we are proud of, we offer an enhanced provision which costs more to deliver than government funding provides.

Therefore, in order to do this, for funded places we ask for a 'Consumable Charge'. However, this charge is optional, and is not a condition of your child attending the setting. If you are unable or unwilling to pay the 'Consumable Charge', then please contact the Nursery Manager to discuss alternative options.
